Online - One-off or monthly

Give.Net is run by Stewardship and facilitates one-off donations or monthly donations. There is also the option to Gift Aid your donation via the Give.Net portal if you are a UK tax payer, this will add 25p to every £1 you give.

Giving via Give.Net makes it easy for us to receive your donation and Gift Aid quickly and is especially helpful to us during the current Covid-19 situation.
